Note:

1. In case where two or more candidates have secured same marks, the order of merit has been determined as per the date of birth of the respective candidate i.e. the person who is born earlier has been placed above.

2. The waitlist has been prepared with 40% or five candidates or as available who are not recommended in the select list of any of the seven posts i.e. Station Operator, Electrician, Lineman/ Wireman, Meter Reader, Assistant Electrician, Asst. Light Operator and Helper (Electrician). In addition the candidates who are recommended against one of the seven posts for which the Commission had conducted common CBT are also included in wait list of other post as per their merit and are marked with asterisk (*).
3. The Commission conducted common CBT for the post of Station Operator, Electrician, Lineman/ Wireman, Meter Reader, Assistant Electrician, Asst. Light Operator and Helper (Electrician) and therefore the select list is prepared as per the merit and preference given by the candidate. The select list may change after verification of documents by the Department/s having posts in common CBT.
